**Workshop 1. Climate Change.** What is the government and the Mayor saying on climate change and environmental issues. How will their proposals impact on our homes and our communities. What are the key issues for tenants?

**Workshop 2. Regeneration, opportunity areas and areas for 'intensification'.** Which areas are identified in the London Plan? How do avoid loss of social rented housing and gentrification? How do we ensure a bottom up approach? Are there ways for tenants living in regeneration areas to link?

**Workshop 3. Lifetime Neighbourhoods.** 'Lifetime homes' have generally been accepted by the policy makers, so why not 'lifetime neighbourhoods? Could we draw together issues identified in our own and other voluntary sector organisation's publications to refine a definition that could be supported by a wide range of tenant and community groups?

**Workshop 4. Making our voices heard on proposals for a new London Plan.** Formal consultation processes commence in Autumn 2009 and a public examination of proposals will take place next year. How do we ensure our voices are heard both within and outside the formal consultation processes?
