Following Government orders the council is making cuts of £31million in the 2012/2013 financial year beginning in April – in addition to the £45 million cut last year.

On top of the 20% VAT rise, soaring gas and electricity bills, and the fact that 30,000 people locally will lose £12m a year in the cuts to Housing Benefits and Council Tax Allowance, local services which many depend upon will be further cut, reduced or

their availability limited due to price increases.

of 28 members of the Cabinet, 23 are millionaires). Their local MP David Ward desperately casts about for "popular" issues [such as reintroducing smoking in working mens clubs (!?!)] whilst voting with the Tories on the key issues.

The Greens have become completely colourless if not almost invisible. Last year they managed to say "me too" to the £45m cuts. Since then they have said nothing.

Labour's publishing of its draft budget document and the range of consultation meetings have been a good step, as far as they go.

However the usual mix of hand-wringing and bland managerialism fails to meet the needs of the times.

They have fallen for the trap

of taking a short term bribe from Eric Pickles to keep Council Tax down this year - which means BIGGER CUTS or an EVEN BIGGER RISE when Pickles pulls the rug next year or later. Across the country councils of many different hues have seen the trap and chosen to put up their local tax.
